

MINUTES OF THE REGULAR MEETING
March 3, 2021

- Call to Order: The Regular Meeting of the Greene Township Board of Supervisors, held in the Municipal Building on Brink Hill Rd., Greentown, PA and live-streamed on the Township's Facebook page due to the COVID-19 pandemic, was called to order by Chair Gary Carlton at 7:00pm, who lead the audience with the Pledge of Allegiance.
- Adopt Agenda: Mr. Obert made a motion to adopt the agenda. Mr. Krautter seconded, voice vote, motion carried.
- Action on Minutes: Mr. Obert made a motion to approve the minutes of the Regular Meeting on February 3, 2021. Mr. Krautter seconded, voice vote, motion carried.
- Announcement of Meetings: None.
- In Attendance: Chairman: Gary Carlton, Supervisor: Gerald Obert, Supervisor: Barry Krautter, Solicitor: Jeffrey Treat, Treasurer: Sandra Oziemblo.
- Solicitor: Jeffrey Treat called an executive session in regards to a legal issue. The board of supervisors and solicitor left the room at 7:03pm and returned at 7:14pm.
- Road Report: Mr. Obert advised that the road crew got the roads all cleaned and plowed and almost every road is bare now. There are some icy spots from runoffs that have been cindered.
- SEO Report: Report received from Glen Martin.
- Solid Waste/Sign Report: Reports received from Amanda Seagraves and Sandra Oziemblo.
- Unfinished Business: None.
- New Business:
- a. **Appeal Hearings** – Mr. Carlton made a motion to accept the appeal hearings. Mr. Krautter seconded, voice vote, motion carried.
 - b. **Saw Mill Rd., and Valley View Rd. - Paving and Chipping** – Sandra advised the our PennDOT representative is coming on March 16th to assist with the bid package for the upcoming projects on Saw Mill and Valley View Roads. The business has been tabled.

- Visitors (via live-streamed Video comments): Treasurer, Sandra read the following resident's comment:
Kimberly Ray: "Is there a plan to fix the entrance of Creek Rd from Hemlock where the PennDOT station is? The road is terrible with ruts & pot holes created by the state plow trucks." Mr. Carlton advised that that portion of Creek Road is the part that PennDOT uses heavily. Mr. Obert stated that it is in bad condition. Mr. Krautter is going to reach out to PennDOT to see if we can come to a resolution for fixing the road.
Marc Cosgrove: "Can Creek Road be paved?" Mr. Carlton stated that the goal is to eventually pave all the township roads. They pave them in order, starting with the most heavily traveled roads. Since Creek Road is not a school bus route and does not have major traffic, it just needs to be kept up as a dirt road for the time being.
- Adjournment: Mr. Obert made a motion to adjourn. Mr. Carlton seconded, voice vote, motion carried. Meeting was adjourned at 7:25pm. The next regular meeting is scheduled for April 7, 2021.
